### THE MISSION OF THE LAWYER AND PROVIDING LEGAL SUPPORT



The year 2023 ends with the announcement of the completion of training courses, and a free training course has been announced for male and female lawyers in Upper Egypt, as a completion of the Women's Economic and Social Empowerment Program.

Women's Economic and Social Empowerment Program is funded by the USAID and is implemented by Pathfinder International in cooperation with the National Council for Women (NCW) and the Gender and Legal Expert House (GELEH).

The project will continue its progress by organizing free training courses for female and male lawyers in Upper Egypt (Sohag, Qena, Assiut) under the title "The Mission of Lawyer and Providing Legal Support". This is aimed at building the capacities of young lawyers in the field of advocacy and providing direct and electronic legal support. The course will be held in Upper Egypt governorates (Sohag, Qena and Assiut) during the months of January and February 2024.

It will cover several topics, including:

- Introduction to the "Mohamek" platform for providing online legal consultations and support
- The concept of violence and the laws that govern it
- How to listen, provide legal advice, and read the case file
- Violence, harassment, and electronic crimes
- Practical workshops

Participants in the training will acquire several skills, including:

- Legal analysis skills.
- The proper and appropriate legal response
- Defining the participant with methods of extracting and building evidence.
- Interpretation and application of law skills
- Extracting information from a case and building evidence
- Developing negotiation skills and how to implement different negotiation strategies during the contract preparation stages
- How to draft contracts in terms of the accuracy of choosing terms.
- Interpreting contracts and defining its loopholes.
- The techniques and methods of providing legal consultations.
- Developing the technological skills.
- How to avoid work stress

## LEGAL INFORMATION

ARTICLE 37 OF THE LAWYER'S ACT NO. 17 OF 1983, AS AMENDED BY LAW NO. 147 OF 2019, STATES IN ITS LAST PARAGRAPH THAT "HE ALSO HAS THE RIGHT TO ISSUE LEGAL OPINIONS, PREPARE CONTRACTS, REGISTER THEM, AND CARRY OUT ALL OTHER LEGAL WORK." THEREFORE, WE FIND THAT THE LEGISLATOR HAS EXPANDED THE AUTHORITY OF THE LAWYER REGISTERED AT THE LEVEL OF APPEAL AND AUTHORIZED HIM TO ISSUE ALL LEGAL CONSULTATIONS, WHETHER ORAL OR WRITTEN; DUE TO THE EXPERIENCE HE HAS GAINED FROM WORKING FOR SEVEN YEARS IN THE HALLS OF THE COURTS.

# Legal Concepts



## HUMAN RIGHTS INSTRUMENTS AND BASIC PRINCIPLES ON THE ROLE OF LAWYERS:

Whereas the Body of Principles for the Protection of All Persons under Any Form of Detention or Imprisonment provides that a detained person shall be entitled to have the assistance of, and to communicate and consult with, legal counsel.

Regarding the electronic invoice: According to the Lawyer Syndicate:


- Lawyers who deal with individuals are not required to register for the electronic invoice, and the deadline of 30/4/2023 is not binding for lawyers.
- Lawyers working in lawyers' offices are also not required to register for the electronic invoice.
- Offices that have registered voluntarily in the invoice system, and lawyers working in offices that have registered are not required to register in the invoice system.

## Your Legal Advisor in Family Matters ..Two Girls Drugged, Kidnapped Inside Elevator



After the video of two girls being drugged in an elevator in Egypt and kidnapped by two men was circulated on social media, the Egyptian Ministry of Interior ended the debate surrounding the video, which caused panic among citizens.

In a statement issued on Wednesday evening, the Ministry of Interior revealed that the man in the video is the father of the two girls, who is separated from their mother, who reported the kidnapping incident. It also confirmed that he left the country with one of his daughters of her own free will.

The Interior Ministry statement continued: "The investigation revealed that the father of the two girls and other two persons committed the incident as shown in the video, and that he had left the country on the same date of the incident with his daughter through Cairo International Airport to one of the countries of her own free will and desire, as is recorded by security surveillance cameras."

The ministry's statement explained: "After the procedures were legalized, the two persons were able to be arrested, one of whom is shown in the video with the father of the two girls, and the second is the driver of the car used in the incident. When they were questioned, they admitted to committing the incident as mentioned above in agreement with the father of the two girls for a sum of money. The necessary legal procedures were taken, and the Public Prosecution took over the investigation."

### Your Legal Advisor in Family Matters answers as follows:

For this case, the article number 292 stipulates that: "A penalty of detention for a period not exceeding one year, or a fine not exceeding five hundred pounds shall be inflicted on either parent or grandparent who does not hand over his or her likely child or grandchild to the person having the right to claim that child according to the decision of the judicial authority as issued concerning its guardianship or custody.."

However, this case is a completely different situation. The father of the two girls planned the kidnapping. He hired two men for a sum of money to surprise the girls, which caused them terror. The men then drugged the girls and kidnapped them and travelled outside the country. While carrying them after the drugging, one of the girls fell in the street and they left her lying on the ground. The other girl was able to be kidnapped and taken outside the country. The forensic report stated that the other girl was injured as a result of the incident. Therefore, we are facing a package of crimes that the father and his accomplices may face sentences that may reach life imprisonment.
