A question
Does the lessor have the right to evict the tenant from the apartment if the contract ends and the contract period is 59 years, knowing that the date of the contract is in 2015 and ends in 2047



The Answer:

If the contract was dated 2015 it is subject to the new law that determines the duration of the lease contract. As long as the contract period is specified in the contract, the lessor has the right to claim the apartment after the expiry of the period.



First: You must write your contracts with a lawyer, as only they possess the knowledge on how to draft and document them in line with your interests.

Second: Consult a lawyer before taking .any action that may harm you

Third: Do not delay in filing an urgent complaint if you suffered any harm. If your opponent files a case against you first it will reduce your chances of .winning the case

The House of Representatives initially approved a bill amending laws related to the establishment of some banks:

It further aims on the achievement of equality among all banks thus ensuring a non-discriminatory treatment under the umbrella of the general rules governing banks operating in Egypt, as stipulated in the Central Bank and Banking System Law promulgated by Law No. 194 of 2020

Your Legal Advisor in Family Matters... Educational Guardianship is a Crisis and married women suffer from it too.



he story of the woman "A.M" with the educational guardianship began when her husband moved to another governorate in pursuit of his livelihood to meet the pressures of daily life, which required additional effort to cover family expenses.

As soon as he settled in their new place of residence, they decided to reunite the family by transferring their child to a new school in the area. Whilst the mother attempted to complete the papers at the latest within two days, she was not expecting the denial of her educational guardianship by the school. The school administration assumed that the mother "Does not own the educational quardianship", thus a new journey of family dispersal began, and it is still ongoing for 4 years.

This indicates the lack of the right of the mother to transfer her daughter from one to another school, even though she is married and not divorced. Instead, the school requires the father to submit the daughter's file, withdraw it, or transfer it to another school. The father's inability to take longer vacations in his new job led to the temporary separation of the family and required him to work overtime.

The educational guardianship describes the right to undertake educational matters for the young, starting from enrolling them in schools, to withdrawing files and transferring them if necessary. It is guaranteed to the natural guardian of the child, the "father," as long as the marital relationship exists and the .spouses are not divorced



The educational guardianship was originally decided to achieve the best interest of the young. And despite the right of the mother to educational guardianship, according to a ministerial decision, a lack of intransigence from schools' administrations implementing the decision can be observed. In such cases, the mother is required to obtain a quardianship decision. She must resort to the court according to the husband's location to obtain a judgment. At the competent court she must obtain an order or a ruling to transfer the educational guardianship to her after proving the dangers and damages which may arise due to her husband's physical absence from her and her daughter.
