



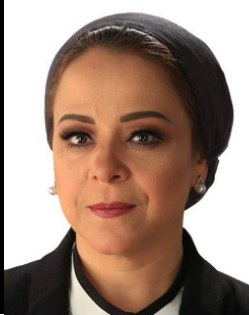

NEHAD ABOUL KOMSAN IN MAURITANIA TO EMPOWER "ARAB WOMEN"



Nehad Aboul Komsan Takes Part in High-Level Workshop in Nouakchott on Advancing Women's Issues in Legislation and Public Policy

Cassation lawyer and prominent international expert on human and women's rights, Ms. Nehad Aboul Komsan, who also chairs the Egyptian Center for Women's Rights, took part in a high-level regional workshop held in Nouakchott from May 19 to 21, 2025. The event was convened by the Arab Women Organization in collaboration with the Ministry of Social Affairs, Childhood, and Family of the Islamic Republic of Mauritania. It was held under the distinguished patronage of Mauritania's First Lady, H.E. Dr. Mariem Mohamed Fadel Al-Dah, a member of the Arab Women Organization's Supreme Council, and attended by Dr. Fadia Kiwan, the Organization's Director-General.

Ms. Aboul Komsan chaired the opening session of the workshop and delivered a keynote speech on mainstreaming gender issues in public policies and legislation. She presented Arab and international experiences in achieving gender justice and linking them to the Sustainable Development Goals (SDGs). The workshop was marked by the participation of a distinguished group of experts from Maghreb countries and concluded with a set of recommendations and a national roadmap aimed at empowering women through inclusive legislation that upholds human rights and promotes equal opportunities.

THEY ALSO CONTRIBUTE TO COMBATING VIOLENCE AND DISCRIMINATION AGAINST WOMEN AND STRENGTHENING THEIR ACTIVE ROLE IN ECONOMIC AND SOCIAL DEVELOPMENT. THUS, EMPOWERING WOMEN BECOMES NOT ONLY A MATTER OF HUMAN RIGHTS BUT ALSO A KEY DRIVER OF INCLUSIVE AND SUSTAINABLE GROWTH FOR SOCIETIES.



LEGAL INFORMATION

THE UNIVERSAL DECLARATION OF HUMAN RIGHTS, ADOPTED BY THE UNITED NATIONS GENERAL ASSEMBLY ON DECEMBER 10, 1948, IS CONSIDERED THE FIRST INTERNATIONAL LEGAL INSTRUMENT TO PROMOTE THE LEGAL EMPOWERMENT OF WOMEN. IT STATES THAT "ALL HUMAN BEINGS ARE BORN FREE AND EQUAL IN DIGNITY AND RIGHTS" AND AFFIRMS THAT EVERYONE IS ENTITLED TO THESE RIGHTS "WITHOUT DISTINCTION OF ANY KIND, INCLUDING SEX.

Legal Concepts



The 1952 Convention on the Political Rights of Women granted women the right to vote and to be eligible for election. The 1979 Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) is considered the most comprehensive international instrument for women's rights.

The 2019 constitutional amendments permanently allocated no less than 25% of parliamentary seats to women. 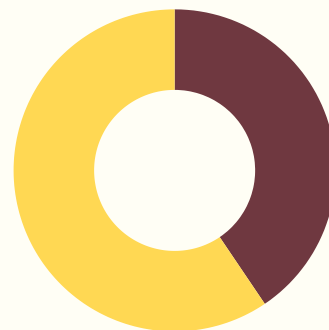

Your Legal Advisor in Family Matters..A 19-Year-Old Young Man Cries Out After His Father Prevents Him from Traveling to His Mother in England!



"My name is Mohannad Ahmed Mohamed Tawfiq, from El-Mahalla El-Kubra. My parents divorced 10 years ago. After the divorce, my mother took me and my younger sister to live in England."

He continued: "I've been studying there, and everything has been going well. I returned to Egypt for a short vacation to visit my older sister, but I was shocked to find out that my father had filed a travel ban against me. For six months, I've been trying to convince him to let me leave, but he refuses—out of revenge against my mother because of past conflicts between them."

The young man added: "I've tried everything to persuade him. I even brought people to speak to him, but he keeps refusing. One time I went to his house, and he beat me and shouted at me. He told people in the street I was a thief, and they chased me, thinking it was true—if it weren't for my friends stepping in, I don't know what would've happened. I just don't know what to do anymore to be able to travel back!"

Your Legal Advisor in Family Matters answers as follows:

The general principle is that a father cannot absolutely prevent his children from traveling without justification, especially if the mother has custody. However, either the father or the mother can appeal to the court to request a travel ban on their children in specific, justified cases.

Appealing to the Provisional Affairs Judge / Family Court:

The father (or mother) submits a request to the Provisional Affairs Judge in the Family Court to seek a travel ban for their children. The request must be justified, meaning it should clearly state the logical reasons and genuine concerns that lead them to seek the ban.

In cases where both parties don't agree: If the child is a minor, their travel outside the country often requires the consent of both the guardian (usually the father) and the mother (the custodian), except in certain cases determined by the court.

If a travel ban order has been issued, the affected party can appeal this order to the court within the legal timeframe. They must provide evidence demonstrating the absence of legal justifications for the travel ban, as it is an exception and a restriction on an individual's freedom of movement. This freedom cannot be curtailed except with strong legal justifications, as stipulated by law.
